[Note that "Fams. of Woolwich," p. 55, states erroneously that Samuel m (2) Jane Foster who d 11 Apr 1890.1 Harriet m (2) Bath 22 May 1831 Noah Rogers (Lin Co Marriage Returns, p. 35) with whom she had 5 chn (Thayer, "Preble Fam.," p. 20). Preble (USC, p. 205). In 1880 Harriet, ae 84y, b MA, was living in Brooklyn NY with the family of her son-in-law and dau Edward and Harriet A. Summers (USC, E.D. 56, p. 248C).

Kelley, *Wilmington Records of Births, Marriages and Deaths, from 1730 to 1898* [1898], p. 15; his parents' marriage on 1 Dec 1785 recorded in *Vital Records of Reading, Massachusetts, to the Year 1850* [1912], p. 298), d Woolwich 19 Dec 1865 ae 79y (Thayer, "Preble Fam.," p. 19). Dr. Buck studied medicine with his bro Ephraim in Malden MA and began his practice in Woolwich in 1816, which continued until his death (Rev. Henry O. Thayer, "Buck Family," typed by Samuel D. Rumery [TS, MHS, 1928], pp. 4–5). He was found dead in his carriage at his house upon arriving (ibid., p. 6). On 27 Nov 1818 Charlotte Preble of Woolwich, spinster, conveyed to her bro Samuel Preble her interest in the real estate of the late Samuel Preble, deceased (Lin Co deed 115:212). In 1850, Cleveland Buck, ae 61y, physician, and Charlotte, ae 61, were enumerated in Woolwich with their son Samuel P. Buck (USC, p. 241).

town VR, 2:168), d 11 Nov 1869 ae 79y ("Fams. of Woolwich," p. 38). He m (2) bef 1860 (USC) Isabella McKown (ibid.), b Boothbay 30 Oct 1806 dau of John & Sally (Harris) McKown (Greene's Boothbay, p. 579; in 1850, Isabella, ae 43y, was living in the household of her father, John, at Southport, USC, p. 69), d 21 Jun 1895 ae 88y ("Fams. of Woolwich," p. 38). David was captured twice in the War of 1812 (Woolwich Historical Society, History of Woolwich, Maine: A Town Remembered, comps. Burnette Bailey Wallace and Frances Soule Maher [1994], p. 176). On 1 Oct 1817, Sally W. Preble of Woolwich, spinster, conveyed to Samuel Preble of Woolwich, mariner, her interest in the real estate of the late Samuel Preble deceased, with the encumbrance of the widow's dower included (Lin Co deed 115:212). In 1850, David G. Stinson, ae 60y, and Sarah W., ae 58y, were living in Woolwich with their family (USC, p. 239). In 1860, David G. Stinson, ae 68y, retired shipmaster, and his 2nd wife Isabella, ae 52y, were enumerated in Woolwich (USC, p. 490). Living with them was Mary McKown, ae 17y, probably a niece of Isabella (and prob the Mary McKown, ae 4y, living with John McKown in 1850 USC, Southport, p. 69).
