 of our father Adam Barbour late of Westbrook deceased said
 Estate is situated on the Northernly side of Presumpscot River
 adjoining the homestead of the late Capt Jonathan Paine with
 the exception of that part of said Estate which is set off to the
 Widow of our father as her dower, and the Mill privilege on said
 Estate with all the appurtenances and privileges of said Mill
 Privilege said dower and Mill privilege is not intended to be
 conveyed by this instrument to said Pride nor any other prop-
 erty of said deceased but that which was included in the
 homestead farm besides that which is reserved above
